Canada says it is, "seeking to make the *Indian Act*'s registration and band membership provisions more consistent with the UN Declaration, until a clear consensus on a way forward on comprehensive change or the Act's repeal is possible".

2nd Generation Cut-Off | Section 10 Voting Thresholds

Last week, Minister of Indigenous Services, the Honourable Patty Hajdu, and Parliamentary Secretary Jenica Atwin issued a call for proposals to First Nations to "explore solutions to the Second Generation Cut-Off and Section 10 Voting Thresholds." This marks the first step in Phase 2 of the Collaborative Process called the "Consultation Activities and Events Stage". Phase 2 has been co-designed and co-developed among Canada and First Nations. I, as the Commissioner on Citizenship, along with the Anishinabek Nation, participated in Phase 1, the "Co-Development and Information Sharing Phase."

Canada's strategy is to amend the *Indian Act* and "consult with First Nations and other impacted Indigenous groups to support the co-development of opt-in alternatives to the *Indian Act* registration and membership (First Nation citizenship)."

I continue to advance our E'Dbendaagzijig Naaknigewin and the one-parent rule that we achieved consensus at our Grand Council Assembly in 2008. Our solution to the Second Generation Cut-Off, Voting Thresholds, and the *Indian Act* is our Inherent Rights, Anishinaabe Law, and our Treaty Rights.

I urge First Nations to apply for the funding to investigate these issues. We have a team to assist you.

Bill C-38

Included in the discussion are "persisting inequities" within the *Indian Act* such as enfranchisement. Bill C-38 was introduced in December 2022 and currently sits at the Second Reading stage.
